The Corporation subscribes to the following Statement of Faith:

We believe there is one living God, eternally existent in three persons: The Father, Son and Holy Spirit, equal in power and glory; that this triune God created all, upholds all, and governs all.

We believe that the Scriptures of the Old and New Testament are the inspired and inerrant Word of God, and the infallible rule for all faith and practice.

We believe in God the Father as an infinite, personal Spirit, perfect in holiness, power, wisdom and love; that He concerns Himself mercifully in the affairs of men; that He both hears and answers prayer, and that He saves from sin and death all who come to Him through Jesus Christ.

We believe in Jesus Christ, God's only begotten Son, conceived by the Holy Spirit. We believe in His virgin birth, sinless life, miracles and teachings, His substitutionary atoning death, bodily resurrection, ascension into heaven, personal intercession for His people and His personal, visible return to earth.
